The JISA investments will be, and must remain in, the beneficial ownership of the investor and must not be used as security for a loan. The title to the JISA investments will be registered in the name of James Brearley's nominee.

Share certificates or other documents evidencing title to JISA investments will be held by James Brearley's nominee or as we may direct.

James Brearley will arrange, if the investor elects, for the investor to receive a copy of the annual report and accounts issued by every company or other concern in respect of shares, securities or units which are held directly in the JISA.

James Brearley is under an obligation if the investor so elects, to arrange for the investor to be able to:

- attend shareholders, securities holders' or unit holders' meetings to vote.
- receive, in addition to the annual report and accounts, any other information issued to shareholders, securities holdings or unit holders.

James Brearley's will satisfy themselves that any person to whom they delegate any of their functions or responsibilities under the terms agreed with the investor is competent to carry out those functions and responsibilities.
